# Charitable Giving

The Hinesburg Police Department set up a fund to help Brisson pay for the surgery. A motion was made to donate \$200 to the fund; members voted on and passed the motion.

And that's how the Charitable Giving committee was resuscitated. At this point, there is no plan on how the committee will move forward, but I have a few ideas. One is to add to the membership form an option to donate \$5 to the Charitable Giving committee, to be matched by the general fund. I would take bi-annual nominations for donation candidates, to be approved at the spring and fall meetings, or on a case need.

# MINUTES—NOMAD FALL MEMBERSHIP MEETING

November 18, 2007

In attendance: 14 proxies; 17 members  
Meeting called to order at 2:04 p.m.

### OLD BUSINESS

#### Approval of Spring Meeting Minutes:

Caroline McKinney moved to approve the minutes from the Spring Membership Meeting and Roberta seconded the motion. The minutes were approved by unanimous vote.

#### Approval of Special Meeting Minutes:

Caroline McKinney moved to approve the minutes from the Special Membership Meeting (held on September 26, 2007) and Patty McMahon seconded the motion. The minutes were approved by unanimous vote.

### 2008 PROPOSED BUDGET

Linda Ladd presented a revised budget from the budget posted on the website. The revised budget includes \$50 in miscellaneous income and \$75 in interest income which were inadvertently left off the first proposed budget. As a result, NOMAD's projected loss for 2008 is \$11 rather than a projected loss of \$136.

#### Camp NOMAD

Linda received several emails regarding the Seminar Committee's subsidy request of \$4000 for Camp NOMAD. The reason the Seminar Committee receives a subsidy is to keep seminar costs down so the seminars will be more affordable for our members. At the time the budget was

proposed, the Seminar Committee had a target income figure for the camp and were going to work backwards (in terms of the number of teams) to determine the cost of the seminar for each team. There will be 16 to 20 teams (pending the Seminar Committee meeting.) With that number of teams, the seminar will cost about \$200 per team for 3 days of camp. The Seminar Committee really wanted a summer training experience. Initially, the thought was to hold a summer seminar, but then someone proposed the camp idea. The Seminar Committee discussed ways to keep it affordable so that members could experience what it was like to attend a camp. Karen Clark indicated that we previously have had 3 seminars a year and have had difficulty filling them and have had difficulty getting people to work the seminar.

#### NADAC

There was a question from the floor asking why the NADAC budget is different this year as compared to last year. Last year's budget was used as a guideline only. Since we are only having a one ring trial some expenses will be less (such as equipment delivery since we are only using Erin's equipment and do not have to bring our own equipment.)

Billie Marsh asked what the procedure was for committee members to obtain more money than was budgeted for their committee (such as a significant rise in gas prices affecting the cost for seminar

instructors to get to NOMAD). Any committee that needs more money should go to the Steering Committee with their committee's recommendation regarding additional funds.

#### Barn rental fee

The Wildwood barn rental fee includes the port-o-let. The fee is \$50 more per month than last year because Stephanie has incorporated the money for driveway repair into the monthly fee rather than seeking funds from us at the end of the season. Lynne von Trapp indicated she would speak with Stephanie about the existing potholes at the start of the driveway.

#### Equipment

It was suggested that we keep what equipment is not needed for practice in storage. With only one barn in use this winter, it will be easier to keep the equipment in good condition that is used for trials. The expensive equipment (like the items we purchase from Max 200 last year) will not suffer as much wear and tear being moved in and out of the trailer repeatedly. Kit Erskine has completed an equipment inventory and will next delineate where each piece is located. Hopefully, we can get into a system for organizing and moving the equipment. The teeter base and the dog walk supports are now in the Wildwood barn

Kit Erskine moved to approve the 2008 proposed budget; and Carla Medved seconded the motion. The Budget was unanimously approved.

## **COMMITTEE REPORTS**

### **Practice**

Kit Erskine gave the Practice Committee report. He indicated that there was positive feedback from last week's practice. Practices run from 10:45 to 12:45 with the first half of practice devoted to stations and the second half to a nested course. Kit is trying to make the practices a continuation of that morning's class. Last week's class was weave pole entries so Kit set up stations with both channel weaves and a full set of 12. The second half of practice was a standard course, with dogs set up in running order, by jump height. Each handler gets approximately 2 minutes of time on the course to do whatever her or she wants (handlers do not have to run the course, but can just do a piece of it or can run just a portion of it). There were 12 people at the practice and each handler was able to run the course twice. There have been requests for more stations in barn (3, probably rather than the 2 we had last week) so that teams can get more repetitions. Practices are \$5 for each practice or \$75 for whole year.

### **Classes**

Kim Rubin presented the winter classes report. She indicated that there was a high request for the pre-novice class taught by Fiona and for the distance and directionals class taught by Randi. All classes are now full, and a waiting list has been started for each class. Anyone who wants to get onto a waiting list should contact Kim R. There was a question regarding the fairness of selection process because some people were in multiple classes and some people only were in one or none. Kim explained that due to the high demand for the two classes and the difficulty in implementing a completely just selection process, she consulted the Steering Committee and they agreed that the names should be picked out of a hat. Kim noted that simply counting which teams were in multiple classes was not an accurate assessment of the fairness of the selection process since it was only two classes which skewed the results. In pre-

ovice, all but two teams were only in that class. At the time Kim filled the classes, there was space in both weave pole entries and games. In Kim I.'s handling skills class, 8 teams signed up for 7 spots so Kim R. asked Kim I. if she would add one more team (which she agreed to do.)

Kim noted that members can audit classes for free and Kit is going to design the practices to continue what is taught in the morning class. Also, no team should feel practice is too hard for their dog. Any sequence or course can be made easier to make dogs (and handlers) successful.

Kate Carter raised the issue that new members seem to be missing the fundamentals (such as down contacts) and asked if NOMAD wanted to create a system or class to help people learn these things. Carla Medved suggested a training committee and volunteered to teach a prenovice/puppy agility classes one evening a week in the summer. There was concern that NOMAD did not want to be seen as competing with the local agility businesses. Lynne sent around a list for ideas for a training committee.

### **Equipment**

Equipment was discussed above during the budget discussion. We need a chair for next year. Any volunteers? Lynne noted it's not as overwhelming as it first appears. Practice equipment and trial equipment divisions will make things easier. There is also the option the equipment at Roberta's being taken care of by the people who do summer training.

### **Seminar**

Both Fiona and Lynn Smitley's seminars filled, and both were well received. Camp NOMAD is in the final planning stages and Billie Marsh is co-chair. The camp will run August 22 through August 24 (Friday, Saturday and Sunday). The cost will be about \$200 per team and there will be two groups of 8 to 10 teams. One group will be novice/advanced and the other will be advanced/masters. The instructors are Ginsey St. Nickels and Elicia Calhoun. The Seminar Committee is discussing topics to be covered with the instructors (such as crosses, contacts, course analysis.) Both groups will experience all topics. For example, the novice/advance group will be doing contacts with Ginsey in the

morning and will spend the afternoon with Elicia doing course analysis, while the advanced/masters group will do the opposite. There has been some talk about an evening lecture. Teams must sign up for all three days. Lunch will be included. Dogs will need to be trialing (we can't take prenovice dogs here). Instructors will work with whatever the capacities are in their group which is part of the reason we've selected these instructors. It is still being determined which teams will get in, but it will most likely be first come first served. The plan is to have a maximum of 10 for each group. Many details still need to be figured out, such as camping arrangements, auditing, second dogs and bringing spouses who aren't really auditing. All questions should be directed to Billie Marsh.

We will not be having any other non-local people teaching a seminar in 2008. However, if people want to have smaller seminars like we had this year (e.g., Fiona and Lynne Smitley), that is a possibility. The Seminar Committee is hoping for a winter 2009 Leslie McDevitt Control Unleashed seminar

### **NADAC Trial**

Caroline McKinney presented the NADAC trial report. The Committee is trying to make the trial more economical this year and make it smoother and more streamlined. They plan on cutting hospitality costs. Billie Marsh will be ring manager for one day (being shadowed by Judy Frey) and Judy Kessler will be the ring manager for day two. Cory (Erin's husband) will be chief course builder.

### **USDA Trial**

Lisa Barrett and Kim I. were not at the meeting. Lynne passed out a sign up sheet for trial jobs. The trial will be one ring with starters and advanced only.

### **CATS/NOMAD Trial**

Kit reported that Leslie from CATS was at Nationals, and they (Kit, Lynne and Lisa) had a discussion about running the trial. CATS's idea was different from ours but they are amenable to doing it our way: sharing the entire trial whether we take a ring and they take one or we do it jointly. The trial will be 2 rings over 3 days with a DAM tournament on Friday. CATS has

found some lodging options for NOMADers coming down. The baseline objectives for both clubs are to hold a major event for this geographical area and to earn some money. The trial will be on June 6, 7 and 8 at Wheelock Park, Keene, NH. Wheelock Park is a great set up with a huge area and lots of shade. Lynne will keep the club updated through newsletter and the newsgroup.

### **Nominating Committee**

Carla Medved was the chair of the Nominating Committee, along with Judy Mulhern and Caroline McKinney. She reported that there were two positions to fill: Vice President (who would hopefully consider taking on president when Lynne is done in 2 years) and a member at large. Cynthia Gilliland has agreed to be nominated for VP and Kim I. has agreed to be nominated for member at large. Lynne has agreed to stay on as President, Kim R. has agreed to stay on as Secretary and Don has agreed to stay on as member at large. Carla moved to have the new Steering Committee approved and Linda Ladd seconded the motion. The motion passed unanimously. Congratulations Cynthia and Kim R. Welcome to the Steering Committee, Lynne thanked outgoing Steering Committee members Kit (the numbers man) and Karen (the memory keeper and historian) for their assistance. Both received a baseball hat with a LED light ("light the way").

### **NEW BUSINESS**

#### **Newsletters**

To save money and make it easier for Caroline, we are asking everyone that is able to get their newsletter via email. We understand that there are some people who cannot. Currently, about 30 people get theirs by mail. Starting with the January newsletter, all members will receive a newsletter via email unless the member contacts Nancy Dashnaw to let her know they would like to receive it via mail. Future renewal forms and new member applications will indicate that they must make a request to receive a mailed newsletter

### **Membership**

Only one-third of the membership had renewed as of the meeting.

### **Hinesburg police dog**

Hinesburg Police Department is seeking donations to help pay for \$4000 worth of surgery for Tigger, their police dog. Tigger is a German Shepard owned by a police officer. Patty McMahon asked if NOMAD could give a donation. Kate Carter moved to make a donation for \$200 and Kim R. seconded the motion. The motion passed unanimously and NOMAD will donate \$200 to the Hinesburg Police Department for Tigger.

The membership felt that we could be giving donations on a yearly basis for dog related causes. Kate Carter volunteered to head the Charity Committee. Please send any suggestions for donations to Kate.

### **Files on our Yahoo Newsgroup**

Billie Marsh suggested we streamline our information online. It appears we have many old files in the Yahoo newsgroup files section and some of these files are out of date and the most recent versions appear on our website. We agreed that we should remove the old files from the newsgroup and Nan Johnson will have the most recent versions of forms on the website (nomadagility.com)

### **Presentation of plaques**

Lynne presented Patty McMahon and Cayden a plaque for achieving MACH, and Cynthia Gilliland Heather received a plaque for their C -ATCH. Maxine Holmes and Sophie were at a trial (of course) and were not present to receive their plaque for Sophie's MACH. Lisanne Major was also unable to attend the meeting. She and Sally Ride! earned their Canadian NATCH

Meeting adjourned at 4:01 p.m.

NOMAD will be involved in two USDAA Trials in June 2008. The membership voted to do this at a special meeting, and our plans are very exciting. We are doing a three-day trial with CATS (a NH agility club) and our very own two-day, one-ring Starters/PI/Advanced/PII trial in Stowe.

Friday, June 6 through Sunday, June 8, NOMAD and CATS will collaborate in a three-day trial at Wheelock Park in Keene NH. Friday will be devoted to Steeplechase/Performance Speed Jumping Round One and an entire Dog Agility Masters/Performance Versatility Pairs Team Tournament. The Team Tournament includes 5 classes: Tournament Standard, Tournament Gamblers, Tournament Jumpers, Tournament Snooker, and Tournament Relay. The DAM teams are comprised of three different dogs and handlers, and two of the three dogs must jump the same jump height. Performance Versatility Pairs teams have two dogs and handlers.

Team Tournament courses tend to be at about the Advanced level. Team Gamblers is almost always do-able by even Starters dogs, since it rarely requires distance handling. It would be wonderful to have a good number of NOMAD teams. But you can compete in the individual team classes without being on a team.

Saturday and Sunday of the CATS•NOMAD Trial will include all the regular USDAA classes at all levels, as well as a Grand Prix/Performance Speed Jumping Qualifier. Saturday will also include Round Two of Steeplechase/Performance Speed Jumping.

At the CATS•NOMAD trial June 6-8, at Wheelock Park in Keene NH, CATS will provide the equipment for both rings. NOMAD will share responsibility and labor for the trial, and will be completely responsible for running one of the two rings for three days. NOMAD will get 40% of the net profit.

Lynne is working out the lodging arrangements in the Keene area for the NOMADers who will commit to working from setup Thursday morning through Sunday night. We are hoping to rent an entire B&B for Thursday through Sunday. We don't yet know exactly how much space there is at the B&B, or what the individual charges will be. Stay tuned. In addition, our wonderful NOMAD members Elliott and Jane Kaplan have offered us their large indoor training area for NOMADers who can bring their own air mattresses, sleeping bags, etc. We should NOT expect to be entertained by the Kaplans, as they need their peace and quiet too. We really appreciate their generosity in offering this great space to enable NOMAD volunteers to spend the weekend in Keene without hotel expenses.

The very next weekend, June 14-15, NOMAD will hold its USDAA Trial in Stowe. Because of all the work going into the CATS•NOMAD trial, we hope and expect that our Stowe trial will require only one ring. NOMAD's Stowe trial will be limited to dogs competing in Starters/PI and Advanced/PII. We won't offer Masters/PIII classes. The main purpose of our Stowe trial is to provide a local trial for our members, particularly our less-experienced members who may be reluctant to travel to trials.

So there's a lot to look forward to—and work on—during our long winter.
