**Everyone’s A Star!**

**March 10 & 17; 9:30-11:30 a.m.**

This class will look at opening sequences from a variety of courses (two per week). Participants will learn the best way for their teams to handle each sequence. Teams do not need to be trialing, but should be confident on all obstacles and be able to sequence at least eight. The classes will be videotaped and available for download via a link sent by email, along with an informal “critique” of each run. Cost is \$42/team.

**Start-line Stays**
