# ATTAINMENT

Attainment, now that's a word you don't hear used every day. It's a very special word because it includes both the process as well as the outcome as it relates to goals. It is important that you understand why attainment is important to your growth in agility.

There is a big difference between accomplishment and attainment. Frank Jones paid income tax on just over \$1,000,000 last year. Frank sold his business. For over 10 years Frank had labored, learned and fought to succeed. Now the business was worth a small fortune and Frank was ready to move on. Sam Smith also paid income tax on just over \$1,000,000 as well. Sam bought the lucky lottery ticket.

Both men accomplished receiving a million dollars. But Frank became something in the process as well. Attainment is both becoming and accomplishing. Sam only accomplished. I'm quite certain these two men are affected differently by their accomplishment. Sam did not have to grow, to change, to become anything new or better to be a millionaire. All he had to do was pick a set of numbers. Frank became something. He became someone who knows how to build and run a business worth a million dollars. You see Frank can do it again. Any time he chooses to. For Sam, repeating his luck is almost impossible.

ACCOMPLISHING is how we measure the EXTERNAL

BECOMING is how we measure the INTERNAL

ATTAINMENT = ACCOMPLISHMENT + BECOMING

During the four-year period from 1972 to 1976 I picked up a 13 pound rifle over 200,000 times, commanded a 250 man company, taught over 2000 classes, won 8 world titles, 7 national championships, set 5 world records, designed the rifle I would use in the Olympics, developed a mental management system and became a father of twin boys. My Silver Medal score in the Olympics in 1972 was only 5 points lower than my Gold Medal score in 1976. I had accomplished only a 5 point improvement in four years, but I'd become so much more.

Accomplishment is easy to measure. It is A, B, C, D and F. It is Gold Silver and Bronze, First, Second and Third. It is qualifying or not qualifying. It is how much money you earn, but not what you are worth. The winner of the Olympic Games is not better than the other competitors because he won. He just outscored his opponents. I cannot even say that. I won my gold medal when my score and the score of the Silver Medalist were the same. I was awarded the medal on a tie-breaking rule. A winner is not better. He just performed better on that day. That's all!

Accomplishment is all about what you do. Attainment is also about who you became in the process.

What seems to be lacking in the world's volume of work on performance enhancement, in my humble opinion, is a different way of describing what those of us that compete are striving for. We are not only seeking to win. We are also seeking to discover. We not only want to get to the top of the mountain we want to strengthen physically, mentally and spiritually because of the climb. We are seeking to become something different than what we were when we started the struggle. We are seeking ATTAINMENT.

Where you finish does not always measure how far you've come. Handlers have as many stories of becoming as they have dogs that they have trained. It is not a question of if you will have to overcome but when. Recently, I had the honor to teach a group of handlers and as we were talking about their dogs I noticed with interest that many of them were rescued from shelters. I heard stories of how some of their best dogs had overcome serious injury to compete successfully. Both dog and handler become something special when they work through adversity together. The bond becomes tighter and understanding is enhanced on both sides of the leash.

The difference between accomplishing and attaining is the personal growth part of the journey to the goal. It's the becoming of something better or greater. All too often we are focused only on the accomplishing, forgetting the power of the becoming part of attainment.

Take a few moments to think of who you are today and how far you have come in your life. Next, take a moment to ponder your future goals. Think about not only what you want to accomplish in this amazing sport but who you want to become in the process. My challenge to you on this day is to focus for just a while on who you need to become in order to make your dreams a reality and how far you have already climbed to the summit of personal success.

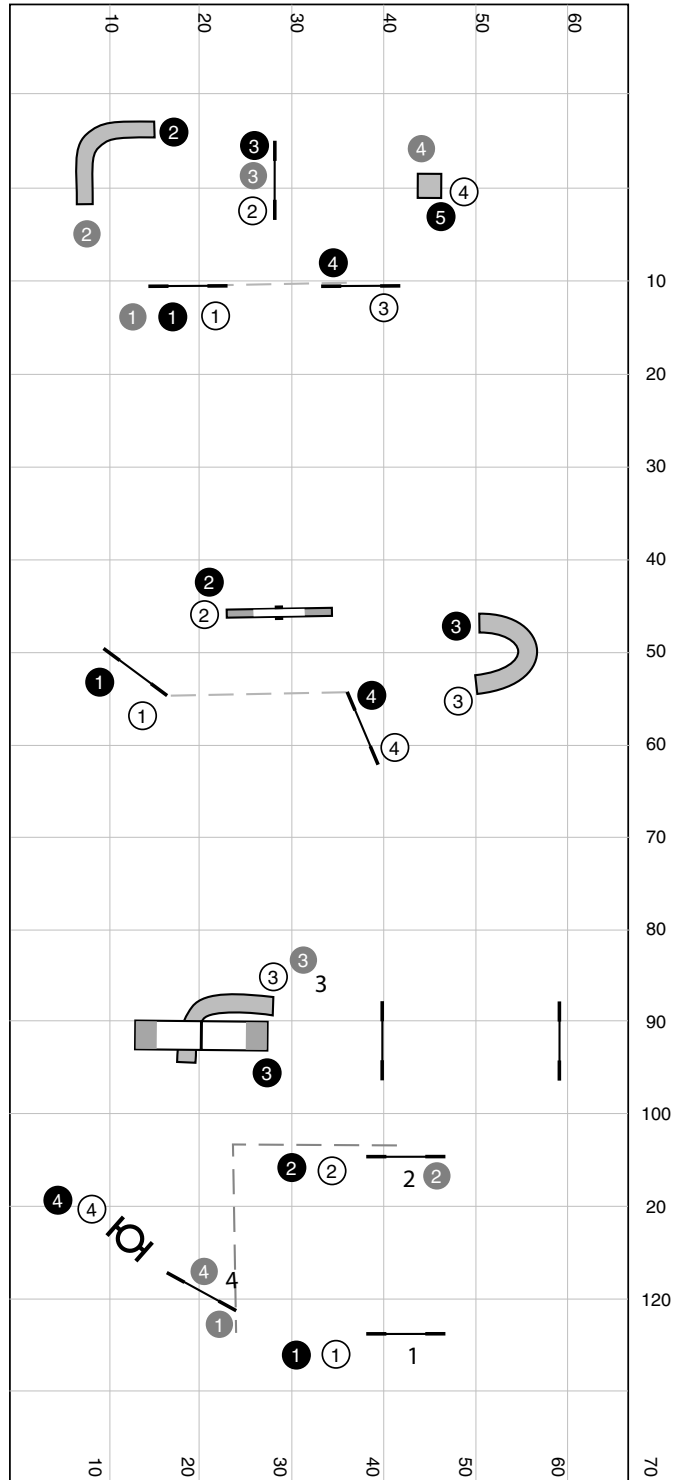
